CONTINUATION ORDER

WHEREAS, recognition was granted to the institution namely, **LOKMANYA TILAK COLLEGE OF EDUCATION, MADHAVA NAGAR, CITY: UJJAIN MADHYA PRADESH** under section 14(1) of the NCTE Act, 1993 for conducting **B.ED.(CO.ED)** course of one year duration with an annual intake of 100 (SEC) (two basic Units of 50 students each) vide order No. WRC/5-6/38/2002/05338 dated 12.09.2002.

2. **AND WHEREAS**, the revised recognition order was issued to **LOKMANYA TILAK COLLEGE OF EDUCATION, NEEL GANGA ROAD, MADHAVA NAGAR, CITY: UJJAIN MADHYA PRADESH** vide order No. WRC/APP00139/213021/2015/148965, 69, 70, 71, 72, 73, 74, 75, 76 dt. 31.05.2015 for B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16.

3. **AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the WRC in its 255th meeting held on 22-24 June, 2016 and the Committee decided "...issued Show Cause Notice to the institution of the condition maintained in revise order"

4. **AND WHEREAS**, a Show cause notice was issued to the institution on 27.07.2016 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order.

- 1) Staff Profile for the session 2015-2016 duly approved by the affiliating body.
- 2) Originally notarized CLU/NEC/BP and Building Completion Certificate.

5. **AND WHEREAS**, the matter was placed in 306th Meeting held on April 29th -30th 2019 and the Committee decided that as under:-

The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

The revised recognition order was issued to the institution on 31/05/2015. The Show Cause Notice was issued to the institution 27/07/2016. The institution has submitted reply of Show Cause Notice on 16/08/2016, 11/01/2019, & 04/02/2019.

On perusal of the reply of the institution, it is observed that the institution has not submitted the following documents:

- *The institution has not submitted original staff profile along with a letter granting approval for the selection or appointment of faculty issued by the affiliating body as per NCTE Amendment Regulations 2017.*
- *The institution has not submitted NEC issued by the competent authority.*
- *The institution has submitted building completion certificate issued from private architects in place of Ujjain Nagar Palika Nigam.*

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order.

6. **AND WHEREAS**, the Withdrawal order was issued to the institution on 09.05.2019.

7. **AND WHEREAS**, the institution has filed an appeal to NCTE, Hqrs on 27.05.2019, "The Appellate Authority vide its appealed order dat. 05.08.2019.

AND WHEREAS, After perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the committee conclude that the WRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the WRC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

8. **AND WHEREAS**, the institution filed a Writ vide W.P No. (C) 8743/2019 13.08.2019 in Hon'ble High Court of Delhi followed by W.P.(C) 8743/2019 & CM APPL. 36193/2019 Order dat.10.02.2020.

9. **AND WHEREAS**, the matter was placed in 324th Meeting held on 23rd to 24th, December 2020 and the Committee decided as under:-

The original file of the institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE and also the direction of the Hon'ble Court in W.P (c) 8743/2019 and CM APPL NO. 36193/2019 and the Committee observed as following:-

The Visiting team be deputed to conduct inspection of the institution to ascertain the exact build up area, as directed by the Hon'ble Court.

In view of the above the WRC decided as under:-

The Visiting Team may deputed to the institution consisting of the following members:-

State Representative of the Govt of Madhya Pradesh in NCTE.

Principal, Govt college, Ujjain.

11. **AND WHEREAS**, accordingly, a Letter was issued on 23.01.2021 and the institution has submitted reply received on 23.03.2021.

12. **AND WHEREAS**, the matter was placed in 336th Meeting held on July 24th to 25th, March 2021 and the Committee decided as under:-

The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:


The Committee considered the inspection report of 2 members Committee and found fir the case for continuation of the recognition for B.Ed course of 2 units (50 Students in each unit).

In view of the above, the Committee decided as under:-

*The Committee decided that the **continuation order** be issued to the **LOKMANYA TILAK COLLEGE OF EDUCATION, NEEL GANGA ROAD, MADHAVA NAGAR, CITY: UJJAIN MADHYA PRADESH** for B.Ed programme for 2 basic units of (50 students in each unit).*

NOW THEREFORE, the recognition of **LOKMANYA TILAK COLLEGE OF EDUCATION, NEEL GANGA ROAD, MADHAVA NAGAR, CITY: UJJAIN MADHYA PRADESH** for conducting B.Ed. .(CO.ED) course with an annual intake of 100 (**SEC**) (two basic Units of 50 students each) is permitted to continue Recognition order from the withdrawal Order WRC/OAPW0139/213021/B.ED/306th/2019/203328 to 203335 was Dated 09.05.2019 with an annual intake of 100 students (two basic units).
